# WEST VIRGINIA BAR FOUNDATION BOARD OF DIRECTORS MEETING ZOOM DECEMBER 1, 2022-12:00 PM

#### **MINUTES**

#### **CALL TO ORDER**

The meeting of the West Virginia Bar Foundation's Board of Directors was called to order by President Lucien Lewin, at 12:00 PM.

Board Members participating were President Lucien Lewin, Vice President Teresa Dumire, Secretary/Treasurer Judge Patrick Flatley, Judge Jack Alsop, Sandra Chapman, Ann Haight, Debra Kilgore, Teresa McCune, Jill McIntyre, David Morrison, Wilbert Payne, Barry Taylor, John Taylor, and Tom Tinder. Executive Director Tessa White and external financial & investment advisor Jamie O'Connor were also present.

## **REVIEW OF BOARD OF DIRECTORS MEETING MINUTES**

The first item on the agenda was a review of the Minutes of the previous Board of Directors meeting, which had been held on September 9, 2022. A motion was duly made, seconded, and passed that the Minutes be approved as presented.

## JUSTICE FUND COMMITTEE REPORT

President Lucien Lewin introduced the Bar Foundation's external financial & investment advisor, Jamie O'Connor, to present an overview of the Foundation's Justice Fund. The Justice Fund consists of four accounts: a bond account, a stock account, a loan repayment account, and a cash account. The combined account value is currently approximately \$973,000. Due to losses in the market, the Justice Fund is down approximately 9.5% this year, as compared to the S&P market decrease of approximately 13%. The loan repayment account was created when the loan was made to the WV Bar Association and is now an obsolete, stagnant account.

The Justice Fund was first created when the Bar Foundation sold its building. It has since reached \$1 million through an anonymous donor's contribution. The Bar Foundation is able to distribute \$50,000 annual from this Justice Fund to provide funding for its annual grantmaking endeavors.

The Committee recommends to transfer the remaining balance in the loan repayment account to the cash account within Merrill Lynch and subsequently close the loan repayment account. The Committee recommends to create a new, separate savings account to be designated toward FY2023-2024 grants. The Committee's recommendations were seconded and passed unanimously.

### **FINANCIAL REPORT**

President Lewin called upon Secretary/Treasurer Judge Flatley to present the financial report. Secretary/Treasurer Judge Flatley stated that the current checking balance is \$79,279. The profit and loss for July – October 2022 was presented. Judge Flatley presented the draft audited financial statements for the period July 1, 2021 – June 30, 2022.

The Board met in Executive Session.

After returning from Executive Session, Judge Flatley made a motion to approve the financial report as presented. Barry Taylor seconded the motion, and the motion carried unanimously. It was suggested to include the balances of the Cash account and the Justice Fund to future financial reports.

Judge Flatley made a motion to approve the audit report, subject to the Audit Committee follow up meeting with the auditor regarding the management comment letter dated December 1, 2022. Ann Haight seconded the motion, and the motion carried unanimously.

Judge Flatley stated that the Form 990 is in process and will be presented at the next board meeting. The Form 990 has been extended and will be filed before the May 15, 2023 filing deadline.

#### **REPORT OF GRANTS COMMITTEE**

On behalf of the Grants Committee, Vice President Teresa Dumire provided the report and recommendations from the Committee. The Committee recommends that the WV Bar Foundation grant \$5,000 to Fayette County Schools and Communities in Schools Fostering Academics Program. After some discussion, a motion was duly made, seconded, and passed to approve the recommendations presented by the Grants Committee.

# REPORT OF FOUNDATION FELLOWS NOMINATING COMMITTEE

President Lewin called upon Judge Jack Alsop to present the report from the Foundation Fellows Nominating Committee. Judge Alsop indicated that the recommended nominations represent individuals who are a great addition to the legal community and have outstanding character.

Executive Director Tessa White presented a Memorandum of Understanding with the WV State Bar to allow the WV Bar Foundation to receive the contact list for all attorneys and judges in the state. A motion was duly made, seconded, and passed unanimously for the WVBF to enter into the Memorandum of Understanding.

Executive Director Tessa White discussed a request from the WV Supreme Court of Appeals, for the WV Bar Foundation to solicit for donations to the Courts Learning Center. The Board requested a written proposal from the Supreme Court. A motion was made to table the discussion until the next Board meeting.
